1. Introduction

This is our first Gloucestershire system-wide Annual Report and reflects the work and commitment of those who lead and engage in research, evaluation and audit.

Whilst Gloucestershire is currently the least research active system in the southwest, it also receives the least research funding. Despite this we have been working hard to improve research activity during 2024/25 by increasing our research visibility, capability and capacity via an Arts, Health and

Wellbeing grant with the University of Gloucestershire (UoG). This work has delivered:

- 14 small grants in research and evaluation
- 4 modules in research and evaluation skills
- 6 part-time PhDs

Increasing research within primary care is another area we have developed by creating and collaborating with five research champion practices.

2. Research, Evaluation and Audit Strategy 2024-27

In June 2024, the Gloucestershire Research, Evaluation and Audit strategy was approved and a copy can be found on our One Gloucestershire web page [Research : One Gloucestershire](#).

Research4Gloucestershire (R4G) is a dynamic and forward-thinking collaboration of a wide range of partners which develops and delivers world-class health and care research, evaluation and audit that benefits the people of Gloucestershire and beyond to help people build resilience, to thrive and live a good life.

Our vision has encouraged and supported an open, curious and caring approach by health and care practitioners to use research and evidence effectively so improving individual professional practice and wider community services.

We are achieving this vision by focussing on 4 key aims:

- Being centred on people and communities
- Providing a capable and enabled workforce
- Working in collaboration and partnership
- Sharing the learning across the system

To support the delivery of this strategy we are using a number of key enablers to success:

- Communication, engagement and co-production
- Data and insights
- Digital and information communication and technology
- Investment and savings
- Organisational development
- Systemwide working



3. Arts, Health and Wellbeing Centre, City Campus, Gloucester

The Arts, Health and Wellbeing Centre (AHWC) is due to open in Autumn 2025 and will be a flagship of the best of Gloucestershire health and social care education through the delivery of innovative approaches, research and education.

Whilst the AHWC has already delivered a number of successful projects, it will provide co-produced learning offers for people and communities, health and social care staff in creative health, social prescribing/asset based community development, personalised care/strengths based approach and a Research Centre of Excellence.

Other facilities available at the City Campus will also include use of an Immersive Suite to use the latest virtual reality to help prevent, improve and maintain health and wellbeing. It can also be used by health and care professionals to test research theories in a virtual space.

4. People and Communities

Research Engagement Network

We set out to build upon our first year of involvement activity and experience, by focusing on what is important to people most impacted by health inequalities and increase their involvement in health and care research. Our goal was to maintain and continue building a sustainable research engagement network (REN), reaching people and communities in Gloucestershire, facilitating the codesign of inclusive research.

This has been approached through collaborative working between NHS Gloucestershire ICB, University of Gloucestershire, NIHR Research Delivery Network (RDN) West of England, Research Champions and five VCSE organisations that are trusted and embedded within some underserved communities.

People and Communities

Research Champions

Health inequalities are unfair and avoidable differences in the health of the population. Some communities are more likely to be affected by them than others. For example, ethnic minority groups, people who are homeless or those who are disabled may find it difficult to access healthcare services.

The same people may also find it difficult to take part in or be represented in research. This happens for a variety of reasons; from studies not looking at issues relevant to these communities, to a lack of trust between community members and researchers.

Research Champions work within communities to understand the barriers to participation in research and start conversations about research. We have currently twelve Research Champions from Inclusion Gloucestershire and the Friendship café.

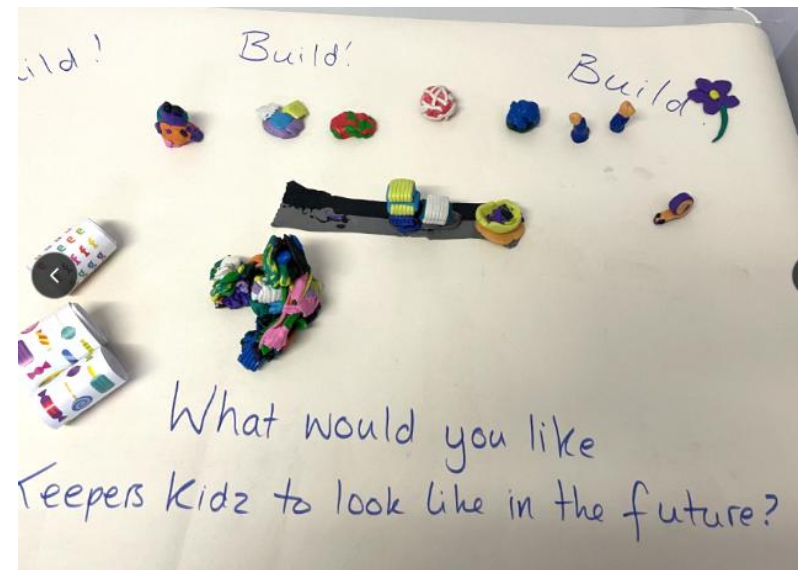


People and Communities

Small Grants in Research and Evaluation

In 2024/25, four voluntary, community and social enterprise (VCSE) organisations were awarded small grants in research and evaluation. These grants were funded by the ICB and UoG and included:

- Stroud District Community Hubs – Community-based Prevention and Intervention for Better Health, *Creative Sustainability*
- Creating Transitions: Non-Attendees to Project Arts on Prescription, *Artlift*
- Barriers to accessing free or low cost talking therapies for disabled people in Gloucestershire, *Inclusion Gloucestershire*
- Supporting Future Talent in Gloucestershire across arts, health and wellbeing, *Create Gloucestershire*

5. Capable and Enabled Workforce

Module in Research, Evaluation and Audit, UoG

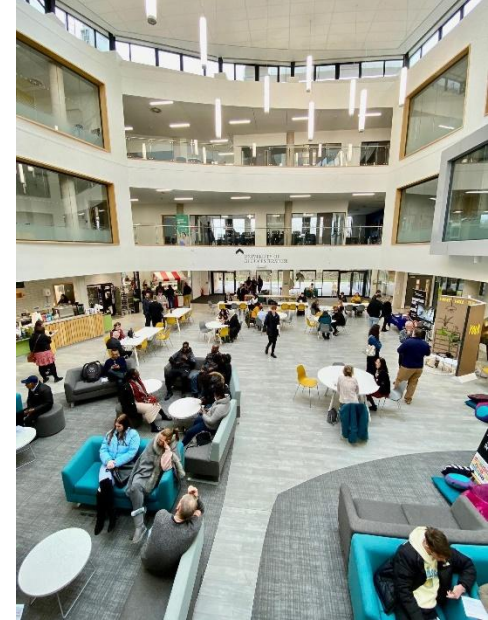
As part of the Arts, Health and Wellbeing Centre's offer to health and care colleagues across the county, 45 participants have now completed their Masters level Research, Service Evaluation and Audit Methods module provided by the University of Gloucestershire, and funded by the NHS Gloucestershire ICB grant.

This module forms part of Gloucestershire Research, Evaluation and Audit Strategy to help increase the skills and expertise of systems partners in health and care research and evaluation.

The module is designed to enable colleagues to engage in the world of health and social care research, service evaluation and audit. Participants explore the use of research evidence to support practice innovation and change, evaluate practice interventions and audit services. The module enables participants to propose and design a research, audit or service evaluation project relevant to their area of practice which will benefit patients, service users, practitioners, services and communities.

Colleagues who have completed the module have gone on to:

- Apply and secure an Arts, Health and Wellbeing Centre small grant to undertake a piece of research
- Pursue business cases for changes to practice benefitting service users, health and care practitioners and their organisations
- Secure external funding to pursue a research proposal, successful students have gone on to apply for Masters by Research/PhD programmes.



Arts, Health and Wellbeing PhDs

The Arts, Health and Wellbeing Centre used the ICB grant funding to support 6 part-time PhD's in the following research areas. The first cohort started in February 2024:

1. Exploring the roles of GP surgery-based link workers and community-based social prescribing workers in the referral process between primary care and VCSE providers of Creative Health interventions in Gloucestershire.
2. Crafting Breast Cancer Survivorship: Ethnic Minority Perspectives of Life in Remission in Gloucestershire.
3. What are the factors that influence effective involvement of patients and their relatives in advanced care planning (including the ReSPECT process) in secondary care?
4. Developing a Practical Pathway to Sustainably Improve Adolescent Wellbeing: Mindfulness and Character Strengths in UK Secondary Schools
5. Is this ethical? Learning from peoples lived experiences of health and social care
6. A focus upon marginalised communities (such as those with Complex Emotional Needs and eating disorders) to explore how they can take an active role in their own health and care through co-produced research.

Students can take up to 6 years to complete their PhDs.



Learning Offers for Arts, Health and Wellbeing Centre

A number of learning offers are being developed and are based upon areas where Gloucestershire is an exemplar, both regionally and nationally, supported by external evaluations.

The following list of topic areas have been proposed as learning and development offers for health and care staff, people and communities:

What is a LARP?



Local Authority Support and Resources

Local Authority Research Practitioners (LARPs) (50% FTE)

Will facilitate research culture and governance within their organisation and support delivery of research opportunities.

Public Health Engagement Leads (PHELs) (3 hours per week)

Will raise the profile of research across their regions and act as key research advocates.

Local Government Directors of Public Health, Public Health Consultants

Via funded sessions, will advise the SCPH on research activity and support the building of research culture, infrastructure and evidence across Local Authorities.

Grassroots Awards

Short part-time awards for those working in Public Health practice to be part of an established research project team.

- Gloucestershire County Council was awarded £50,000 in 2024/25 for a LARP role. Following advertisement, was able to appoint in February 2025.
- The unifying vision for the LARP role is a practitioner dedicated to facilitating research and supporting the development of research governance systems and processes, enabling public health research to happen within Local Authorities and the communities they serve.
- A LARP will do different things in different Local Authorities, tailored to local needs, and depending on the **extent to which a Local Authority is currently involved in research activity**.
- LARPs will be part of the **NIHR Research Support Specialist Centre for Public Health network** and will benefit from bespoke training and development and national networking activities.

6. Collaboration and Co-ordination Research for Gloucestershire (R4G)



During 2024/25 R4G's membership has grown to include members from the Health Innovation Network West of England, VCS Alliance Gloucestershire, Barnwood Trust, Inclusion Gloucestershire (members of the Research Engagement Network), Healthwatch and Research Champions.

R4G has received regular updates on progress being made on the Gloucestershire Research, Evaluation and Audit Strategy 2024-27 and has formed a number of working groups of R4G. Here are some of the highlights from R4G in 2024/25:

- Approval to create a Gloucestershire Research Repository (April 2024)
- Consultation and approval of the Research Strategy (May/June 2024)
- Approval of a Local Authority Research Practitioner role (July 2024)
- Design and consultation on working groups of R4G (August 2024)
- Consultation and approval of a Research Hub (November 2024)
- Consultation and approval of a Research, Evaluation and Audit Strategy Communication Plan (December 2024)
- Approach to decision making and governance arrangements (February 2025)
- Consultation and approval of decarbonisation system wide NIHR bid (March 2025)

Collaboration with other research teams and other systems

During 2024/25, Gloucestershire colleagues working on research have collaborated closely together to include:

- The creation of five Research Champion GP practices who seek funding opportunities and provide peer support
- Forming a collaboration and horizon scanning working group of R4G
- A decarbonisation system wide bid, including health and social care partners, VCSE and Research Engagement Network

Members of R4G have been working with Bristol, North Somerset and South Gloucestershire (BNSSG) ICB and BANES, Swindon and Wiltshire (BSW) ICB, Oxford University and North Bristol Trust on:

- Knowledge Mobilisations Fellows (BNSSG, BSW and Gloucestershire ICBs and ARC West)
- Letters of support from Gloucestershire practices on five applications to develop Primary Care Commercial Research Delivery Centres - NIHR bid (BNSSG, Heart of Bath, Swindon and Wiltshire)
- Becoming a research site for Oxford University - use of virtual reality for psychosis (GHC, Gloucestershire ICB and University of Oxford)

Research horizon scanning, research applications and income

One of the priorities is for Gloucestershire is to become more research active and create funding opportunities. As previously mentioned, Gloucestershire is the least active system in the southwest for both acute, community care and primary care.

A Gloucestershire Collaboration and Horizon Scanning Working Group has been created to seek funding opportunities. A system wide NIHR bid was submitted in March for development of carbonisation pathways for people with frailty. This is a two-stage application process, and health and care partners will find out in June 2025 if it has been successful to go onto the next stage.

Attached in the appendices of this annual report is a list of recruiting studies for both GHC and GHFT which amounts to a total of 98 recruiting studies and 2,229 people recruited.

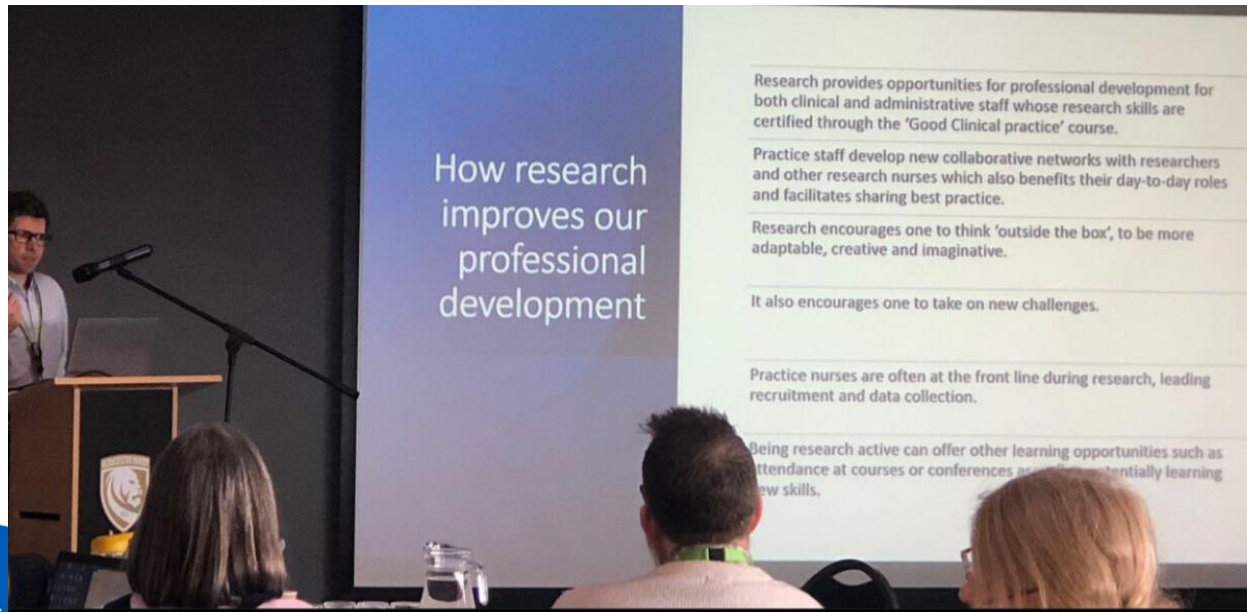


7. Sharing and Learning

Primary care and community research workshop

In April 2024, the ICB arranged two workshops for primary care and community staff to learn about the research support that is available locally and for two of our research active practices to share their insights. The practices were Prices Mill and Phoenix Health Group.

The day was attended by over 100 health and care staff, with more GP practices engaging in research following the event.

Gloucestershire Research Hub

The Gloucestershire Research Hub launched in March 2025 and is an opportunity for researchers to come and speak to health and care professionals, people and communities about their research and then have a conversation. They are relaxed and informal sessions.

The Research Hub meetings take place online once a month and are recorded on Zoom. Attendance and reach is growing each month with between 27 and 50 people attending. Below is a list of the Research Hub talks so far:

Open Research Repository

A business case was approved in September 2024 to create an open (publicly accessible) research repository.

The research repository will include published research undertaken by health and care colleagues working in Gloucestershire. It will showcase the work Gloucestershire is doing to others, both within and outside the county, and worldwide!

The ICB and GHFT are working closely with a company called Atmire to launch the research repository in early July 2025. The repository will be freely available to people and communities with no log in required to learn more about the research work Gloucestershire is doing.



Knowledge Mobilisation Fellows - Research Evidence into Practice

In December 2024, the ICB was awarded three years funding for three part-time Knowledge Mobilisation (KM) Fellows.

KM Fellows play a critical role in bridging the gap between research and practice, working with researchers, key stakeholders in the health and care sectors, patients and the public to support an evidence-into-practice knowledge mobilisation project.

Following an expression of interest advert to health and care partners, R4G chose three projects to take forward as Knowledge Mobilisation Fellows:

1. Group Consultations (Primary Care)
2. Introducing and implementing Hyperthermic intraperitoneal chemotherapy (HIPEC) in the management of ovarian cancer (GHFT)
3. Automated Virtual Reality (VR) Therapy for those aged over 16 with Psychosis (GHC)

Two GPs (Mann Cottage and Overton Park surgeries) have started as KM Fellows to introduce group consultations for people with Type 2 diabetes. The groups include 'a pathway to remission' for Type 2 diabetes and annual health checks. This different approach to support people with diabetes in a group setting will be evaluated later in 2025/26.

8. Evaluations

TheKingsFund>

In January 2025, the ICB commenced work with The Kings Fund to evaluate its Covid-19 vaccination programme and share valuable learnings to support the implementation of successful vaccination strategies across England.

Creating and maintaining thriving, healthier places and communities through a more preventative health system is a core objective for both the ICB and The Kings Fund. As an ICB, we see successful implementation of an overarching vaccination strategy as an important tool towards shifting to a model of preventative care.

This an exciting piece of work as The Kings Fund have a considerable history of working with system leaders, both through their leadership and organisational development function, and in undertaking research and analysis that supports the development of systems.

The full evaluation report and supporting media will be available in December 2025 and will be shared nationally through several platforms.

Small grants in evaluation

Through a grant awarded to the University of Gloucestershire, it created an opportunity for all health and care organisations and the VCSE sector to apply for a small grant to undertake an evaluation. Below is a summary of the small grants in research and evaluation awarded in September 2024. The outcome of these research studies and evaluations will be presented at a showcase event at the new Gloucester City Campus, UoG in November 2025:

9. Audits

Below is a small summary of projects the ICB Clinical Audit team have supported during 2024/25. The key element of support for each audit/project is always threefold:

- The identification of appropriate SNOMED codes to ensure accurate primary care data recording and subsequent evaluation, including Enhanced Services, Primary Care Offer, PCN DES, Medicines Optimisation, CPGs, Safeguarding, PCN projects, specific services such as Connect+Prevent, Public Health projects, linking with Ardens as appropriate.
- The development of clinical system searches to support GP Practices identify their relevant patient cohorts to review.
- The production of clinical audit data to firstly enable GP Practices and PCNs identify their achievement against peers, and secondly to allow teams, such as CPGs, understand their population and inform decision making.

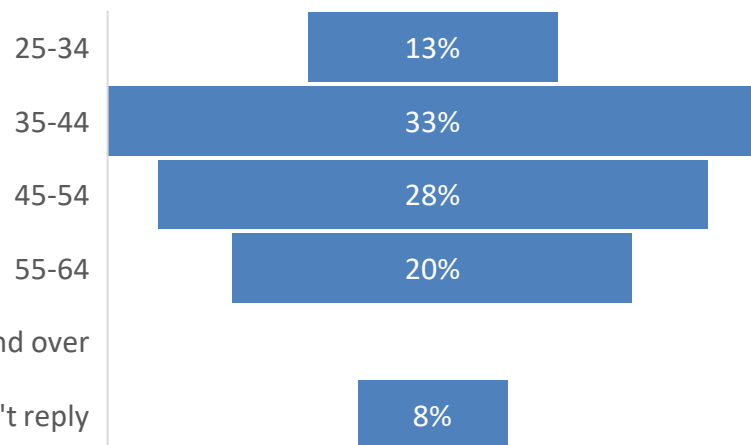

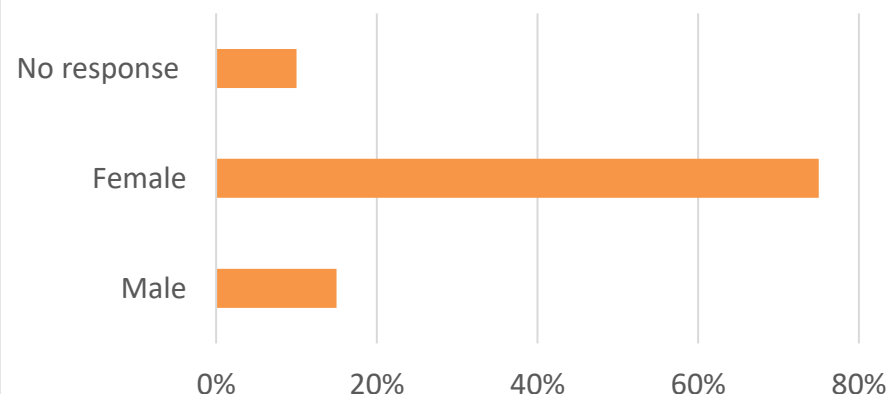
10. Inclusion in Research and Evaluation

Age range of those who applied for AHCW small grants in 204/25

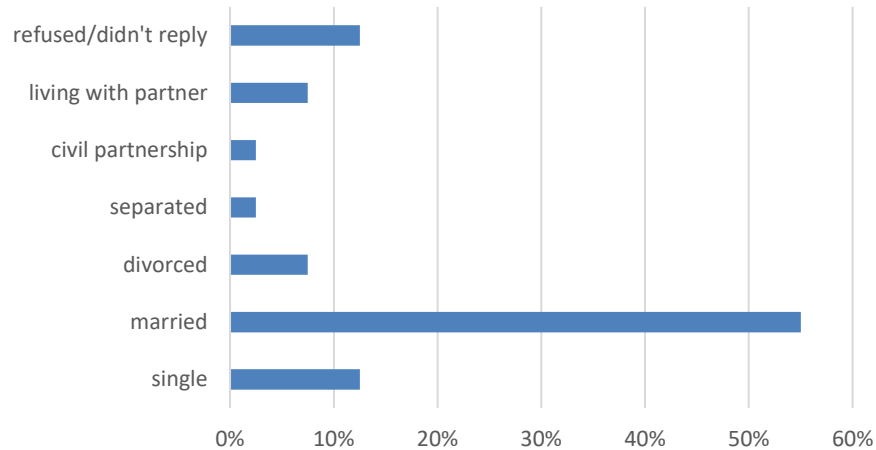


Gender of those who applied for AHCW small grant in 2024/25

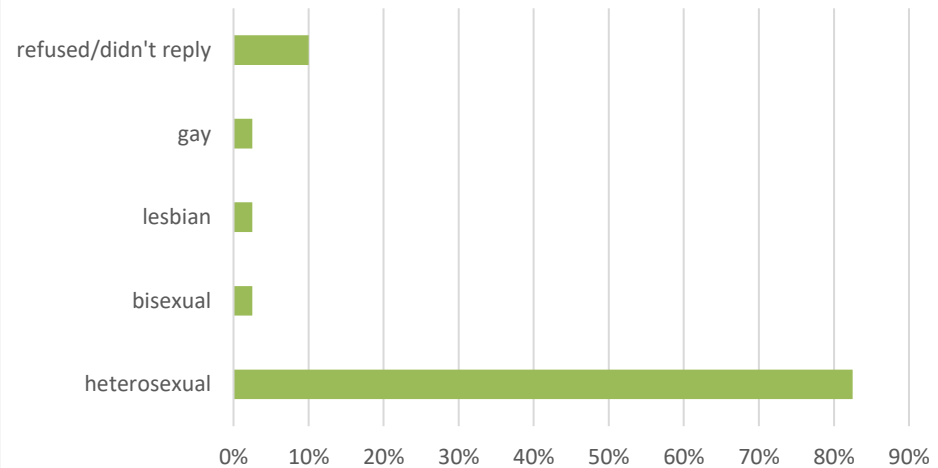

Marital status – small grants in 2024/25

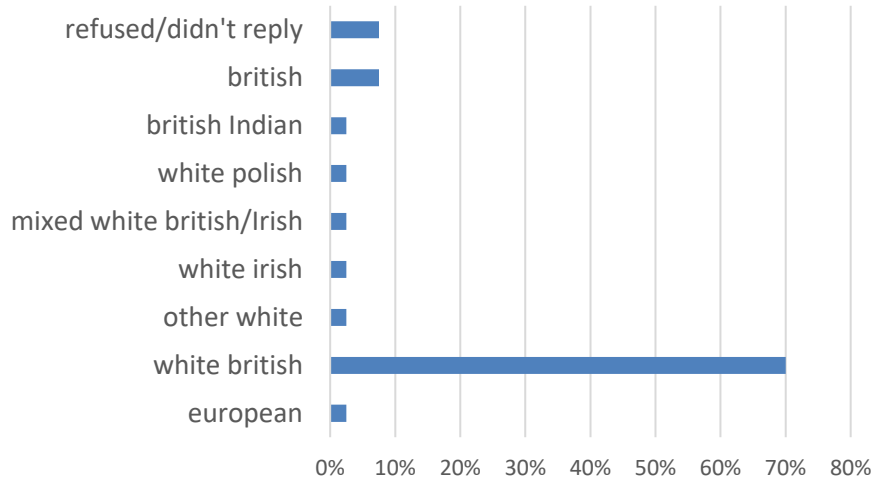


Sexuality – small grants in 2024/25

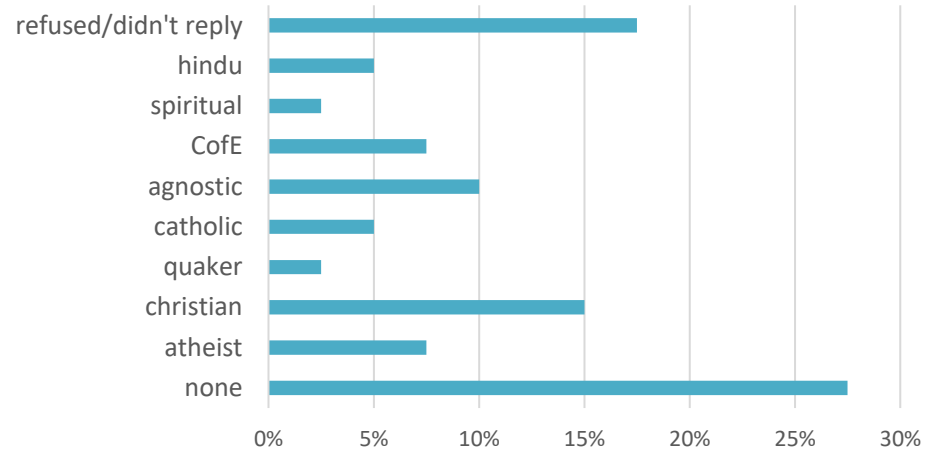

Ethnic origin – small grants in 2024/25

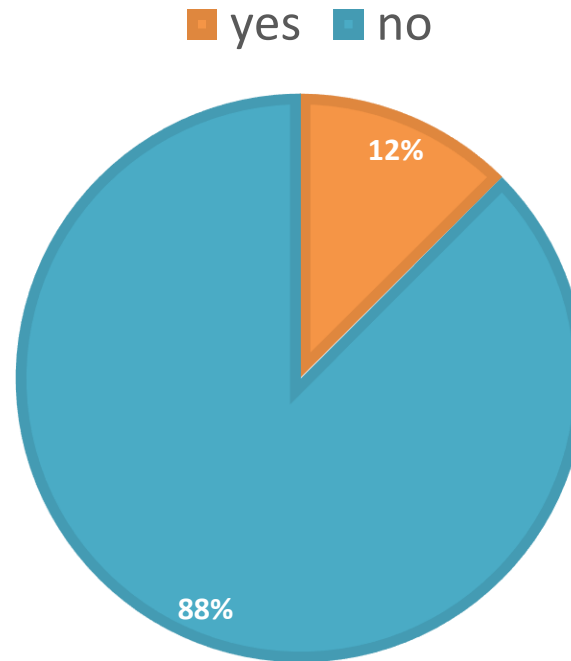


Religion – small grants in 2024/25

We will continue to ensure our application and selection process for research, evaluation and innovation grants remains inclusive and representative of our population.

11. Looking forward to 2025/26

The roles and responsibilities of ICBs will change towards the end of 2025/26 following publication of the Model ICB Blueprint, along with significant savings to be made for the ICB, NHS Trusts and the merger of two schools at UoG. Gloucestershire ICB will also be clustering with BNSSG ICB during 2025/26. This will give Gloucestershire some great opportunities to learn from and work more closely with BNSSG, who are one of the most research active systems in the country.

With the opening of the Arts, Health and Wellbeing Centre in Autumn of 2025, UoG will be offering a new professional doctorate in health and social care leadership from October 2025 <https://www.glos.ac.uk/courses/course/dhsc-doctorate-in-health-and-social-care-leadership/> and a new Masters in Health and Social Care Leadership in September 2026. Through the learning offers provided by the Arts, Health and Wellbeing Centre, Gloucestershire will continue to build its research capacity and capability for health and social care staff, people and communities.

Gloucestershire health and care system will continue to collaborate with other systems and organisations in its endeavour to become more research active and generate research income and capacity.

During 2025/26, we will grow our evaluation methodologies and evidence base to ensure we are commissioning and delivering optimal value-based services and improving outcomes for people and communities.
